

# INDEPENDENT ASSURANCE STATEMENT

To: Japan Tobacco Inc.



Bureau Veritas Japan Co., Ltd. (Bureau Veritas) has been engaged by Japan Tobacco Inc. (JT) and its group companies including JT International S.A. (JTI), which is called JT Group as a whole, to provide limited assurance over their sustainability information selected by JT Group. This Assurance Statement applies to the related information included within the scope of work described below.

## Selected information

The scope of our work was limited to assurance over the following information (the 'Selected Information'):

- 1) The following environmental data through JT Group's business operations for the period of January 1, 2024 through December 31, 2024 included within JT Group Integrated Report 2025 (the 'Report') and JT Global Site (the 'Website'):
  - Total energy consumption
  - Proportion of renewable electricity (%)
  - Greenhouse gas Scope 1 and 2 emissions (Scope 1: limited to CO<sub>2</sub> emissions and fluorocarbons (CFC, HCFC and HFC) emissions)
  - Water withdrawal and Wastewater discharged
  - Waste generated, Waste recycled (including composting, but excluding waste incinerated with heat recovery), Waste incinerated with heat recovery, Waste incinerated without heat recovery and Waste landfilled
  - Total packaging weight
  - Reusable and/or recyclable packaging weight
  - Proportion of reusable and/or recyclable packaging (%)
- 2) The following environmental data through JT Group's business operations for the period of January 1, 2024 through December 31, 2024 reported internally to JT Group only for the purpose of internal management:
  - Total electricity usage
  - Total renewable electricity usage
- 3) The following greenhouse gas Scope 3 Category 1 emissions through JT Group's business operations included within the Report and the Website:
  - Emissions from tobacco leaf and other materials related to tobacco business purchased during the following period:
    - o Tobacco leaf purchased from direct leaf supply: 2024 crop year
    - o Tobacco leaf purchased from third party: January 1, 2024 through December 31, 2024
    - o Other materials related to tobacco business: January 1, 2024 through December 31, 2024
  - Emissions from goods and services purchased by JT (Pharmaceutical Business, Processed

Food Business, and Corporate Divisions) and related group companies for the period of January 1, 2024 through December 31, 2024

4) The following environmental data through business operations of JT (Processed Food Business) and related group companies' offices in Japan for the period of January 1, 2024 through December 31, 2024 reported internally to JT Group only for the purpose of internal management:

- Total waste generated, Waste recycled (including composting, but excluding waste incinerated with heat recovery), Waste incinerated with heat recovery, Waste incinerated without heat recovery, and Waste landfilled

5) The following environmental data through business operations of JT (Processed Food Business) and related group companies' offices in Japan for the period of January 1, 2024 through December 31, 2024 included within the Report and the Website:

- Recycling rate (excluding waste heat recovery)

Our assurance does not extend to any other information from that stated above.

### **Reporting criteria**

The Selected Information included within the Report and the Website needs to be read and understood together with the reporting criteria stated in the Report and the Website.

The Selected Information reported internally to JT Group only for the purpose of internal management needs to be read and understood together with the internal reporting criteria defined by JT Group.

### **Limitations and Exclusions**

Excluded from the scope of our work is any verification of information relating to:

- Activities outside the defined verification period;
- Any other information within the Report or the Website, which is not listed as the 'Selected Information'.

This limited assurance engagement relies on a risk based selected sample of sustainability data and the associated limitations that this entails. This independent assurance statement should not be relied upon to detect all errors, omissions or misstatements that may exist.

### **Responsibilities**

This preparation and presentation of the Selected Information in the Report and the Website are the sole responsibility of the management of JT Group.

Bureau Veritas was not involved in the drafting of the Report, of the Website or of the Reporting Criteria.

Our responsibilities were to:

- obtain limited assurance about whether the Selected Information has been prepared in accordance with the Reporting Criteria;
- form an independent conclusion based on the assurance procedures performed and evidence obtained; and
- report our conclusions to the Directors of JT Group.

### **Assessment Standard**

We performed our work in accordance with International Standard on Assurance Engagements (ISAE) 3000 (Revised), Assurance Engagements Other than Audits or Reviews of Historical Financial

Information (Effective for assurance reports dated on or after December 15, 2015) issued by the International Auditing and Assurance Standards Board.

For the greenhouse gas emissions data, we undertook verification in accordance with the requirements of ISO14064-3 (2019): Greenhouse gases - Part 3: Specification with guidance for the verification and validation of greenhouse gas statements.

### Summary of work performed

As part of our independent verification, our work included:

1. Conducting interviews with relevant personnel of JT Group;
2. Reviewing the data collection and consolidation processes used to compile Selected Information, including assessing assumptions made, and the data scope and reporting boundaries;
3. Reviewing documentary evidence provided by JT Group;
4. Reviewing JT Group systems for quantitative data aggregation and analysis;
5. Verification of sample of data back to source by carrying out three physical site visits and reviewing four sites remotely, selected on a risk-based bases at the following locations:

[Physical site visits]

- JT Head Office
- JT Central Pharmaceutical Research Institute
- TableMark Co., Ltd. Chuo Factory

[Remote review]

- JTI MKT Spain
- JTI GBS Poland
- JT GL Japan
- JTI GSC Kazakhstan

6. Reperforming a selection of aggregation calculations of the Selected Information
7. Comparing the Selected Information to the prior year amounts taking into consideration changes in business activities, acquisitions and disposals

The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement.

Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

### Verified greenhouse gas emissions

We performed our verification work on greenhouse gas emissions data in accordance with the requirements of ISO14064-3(2019).

Verified data in greenhouse gas assertion made by JT Group are as follows.

- Nothing has come to our attention to indicate that the Selected Information has not been properly prepared, in all material respects, in accordance with the Reporting Criteria;
- It is our opinion that JT Group has established appropriate systems for the collection, aggregation and analysis of quantitative data within the scope of our work.
